Water quality tests results for Kala Point are reviewed monthly by Jerrod Davis, (360-586-2510). The finances/procedures are reviewed by Jim Ward, (360-664-1250). If you have questions it would be better to ask those whose job it is to keep our water safe.

We are not powerless. If a significant percentage of our community have concerns, a petition drive representing that number would let Olympia know this. Remember, it's the squeaky wheel that gets oiled.

The rate increase due to the water meter change seems to be about 50% for many.

## ASDC President Mayhall

Raising children with hearing loss is a very consuming task, and ASDC is committed to providing education, support and advocacy to maximize the success of these kids and their families."

If those who feel wronged aren't careful they will be unable to see positive changes even when they happen. Generally, KP residents are well educated, thinking folks who can overcome perceptions and keep an open mind once reminded that it is a good idea.

Let's all take a deep breath and try to look for positive change with this new Board and leadership. There is no doubt that the newly elected Board members are anxious to accomplish such changes. Many of the previously elected Board members are looking for positive future plans, too. Even some members on committees whose procedures were questioned in the last issue of To The Point have called to say they have been trying to exact changes to make their committee more user-friendly.

Kala Point is such a beautiful place. Living here is like stepping into the Garden of Eden. When you walk around the community, neighbors are friendlier than one would usually find. The new Board, the committees in question and residents have a wonderful opportunity. We can take something that is so worthy of effort, and iron out the wrinkles if we try. Logically, we all know that perfection is never possible but it is a good goal.

Soon the new Board will present their goals. The goals over the last decade have changed very little from one Board to another. One change to look for is if the new goals are truly new.

### To The Editor:

In addition to the information on Prescription Drugs by Daphne Kilburn in the July edition, I would like to add further information.

As with USA pharmacies, every pharmacy in Canada quotes a different price...and the hidden charges are different, so I call each and every one whenever I have a prescription to be filled.

I have used the Canadian system twice now and find that each time the best prices (for my needs) were from Surrey B.C. 1-866-600-5262, quoted in USA funds. It is never necessary to travel, however, I chose to drive up the first time. We got the 10 a.m. Port Townsend ferry, visited the doctor (to have your prescriptions rewritten), visited the bank, had lunch and were home on the 4 p.m. ferry, (and this included crossing the border 2 weeks after 9/11). The cost of the ferry is the same as the shipping charge but the advantage is you avoid the 2-3 week wait for the drugs...and it's an interesting day. At the visitor center directly across the border they give you a map and show the route to the doctor/pharmacy.

Also, I followed up on the dot-com sites mentioned in the July edition. Global Drugs is for Canada only. Halfoffmeds.com is a liaison for Canada, but located in Florida. Shari Loomis

## Impressions From the KPOA Annual Meeting

This year's Annual KPOA meeting was more interesting than the previous three years. Generally the business side is the usual busyness stuff that we hope is being taken care of by the Board and various committees as assigned. There seemed to be no surprises. The KPOA version of the results of the Clubhouse use research were interesting. The KPVA represents only 6% of our total residency. Their usage of: the pool/spa was 46%; of the Clubhouse game rooms, etc. was 19%; and of the overall facilities, 35%. If the KPVA results agree, this should help resolve the suit.

On voting for the Board candidates, about 324 families voted. All three candidates received over 300 votes each. On the resolution where the voters were asked to give an up or down approval on the 2001-02 Board and committee actions, 241 voted to approve and 81 voted to disapprove. The disapproval rate was slightly over 25%. That should send a message to anyone in power who is listening. The other resolution to waive an outside audit for this last year, 247 voted to waive, 77 voted to have the audit. Even though both of these resolutions passed, the results indicate that Kala Point citizen trust needs to be re-earned by those holding office here.

During the citizen comment section at the end,

several subjects were brought up as concerns including: recycling bins, speeding on KP streets, not stopping at KP stop signs, property values, reasons for the fresh gravel job on the shoulders of Kala Point Drive, clearing of the downed timber on undeveloped properties, clearing by the KPOA of the downed material on nature trails, open burning outside Kala Point gate, collective bargaining for KP residents with organizations like the cable company, etc., and water issues.

Amazingly enough, the water issue was the one that got the most comment. In the first three issues of *To The Point*, this issue was **not** discussed and barely mentioned. So, the interest in this issue came only from the citizens. *TTP* knows you are educated, intelligent people who think for yourselves, but it is nice to have such a glowing example to prove this premise.

For your information, a comprehensive report on how the KP Utility Company does business and keeps books has recently been completed. The current new Board has it in hand for consideration. In addition, some citizens are looking for options. One mentioned at the meeting that struck quite a lot of wonder was that there are no rules against our drilling our own wells. Two local families are actually discussing this possibility.

One thing for sure, we haven't heard the last on this issue yet. Stand by for the unveiling of the rest of the iceberg!




## Encore Performers Entertaining Continues

seems to be a distinct sense of disregard and disrespect on the part of some Board and Committee members toward KP resident legitimate interests. We hope that the stated purpose of KPOA can be changed from “protecting property values,” to “promoting neighborliness and protecting property values.”

It might also be interesting if a policy statement were formulated that spelled out resident expectations for the Board and Committee member behavior in carrying out their duties in service to all of the community. If this were done, whoever told the Favertys’ daughter to “shut-up and sit down” could and should be dismissed as a committee/board member.


